Please be advised that effective as of July 26th, 2021, **Eftec (UK) Limited** a company registered under the laws of England and Wales with its registered address at 1 Beauchamp Court, Victors Way, Barnet, Hertfordshire, EN5 5TZ will change its name to **Fastair Aero Limited**. The Company Registered Number 06937302 remains allocated to the company as do the VAT and EORI Registration Numbers and banking details, albeit the bank account name will change to Fastair Aero Limited. ASA Certificate will be reissued, and ASA Certificate Number will be changed. We will provide you with reissued ASA Certificate as soon as it is available.
